## **CHAMPION OF EDUCATION**



The RRCC Foundation Board of Directors recognized Barber Nichols, Inc. for their commitment to changing lives through education. As champions of education, Barber Nichols Inc. has funded nearly \$100,000 in scholarships to students at RRCC.

## **EXCELLENCE** at Red Rocks Community College



This past year, RRCC officially opened the doors on a brand new, state-of-the-art student engagement center called The Hub. The Hub provides students with opportunities for real-world education and reflection with a mixture of impact practices, experiential learning, and equity-focused campus engagement. Through The Hub, students have access to a wide array of offerings, from entrepreneurship guidance to design-thinking and collaboration in the IDEA Lab, community engagement through service learning, study abroad, intercultural opportunities, internships, and honors options.

### **CYBER SECURITY**

The RRCC Cyber Team placed second at the Rocky Mountain Collegiate Cyber Defense Competition. This year's competition had students defend a business environment network from cyber-attacks while operating under the needs of the business and reporting to executives. The team was extremely proud of their achievement. Not only did the team bring home second place overall, they were the highest ranked Colorado school, even while competing against four-year schools with graduate level members. We are very proud of our Cyber Team, and they have been amazing representatives of RRCC everywhere they go.

## COLORADO HEALTH FOUNDATION GRANT

The RRCC Foundation and the RRCC Physician Assistant Program were awarded a \$342,273 grant from the Colorado Health Foundation (CHF). The CHF grant will help to expand the number of qualified PAs who practice primary care, addressing both a statewide shortage of primary care providers, and an urgent community need for primary care providers who specialize in aiding underserved communities. The proposed grant project will pair competitive fellowship stipends with specialized primary care training and interprofessional education.

The 2015-2016 Academic Year saw the Red Rocks Community College Foundation partner with the Harvey Family Foundation. The goal of this partnership was to help support low-income or at-risk STEM students who have the intent to transfer to Colorado School of Mines (CSM), after they graduate from RRCC. The Harvey

Family Foundation was created by Hugh Harvey and his wife, Michelle, with a goal of making meaningful contributions to their community. The Harvey family had a strong connection to CSM, and with RRCC having a transfer agreement with CSM, it was a natural fit to extend a helping hand to the next generation of CSM students starting their journey at RRCC.

The Harvey Family Foundation Scholarship is one of the most prestigious awards a student can receive at RRCC. Each scholar receives an award of \$5,500 for the Academic Year that covers the majority of their tuition and fees. With a high award, comes higher standards too. Each Harvey Scholar is expected to be a full-time student, which amounts to 12 credit hours per semester. However, many Harvey scholars will take on an even more strenuous course load. Historically, Harvey scholar's average more than 17 credit hours each semester. Harvey scholars are also expected to maintain a 2.75 GPA, each semester, and receive no less than a "C" in their CSM transfer courses. Once again, our Harvey scholars go above and beyond their requirements. As Harvey scholars, our students have earned a 3.5 cumulative GPA!

The Harvey Family Foundation scholarship has had a strong impact on RRCC students. Since inception, 36 RRCC students have received over \$192K worth of Harvey scholarship awards. With this generous support, Harvey Family Foundation scholars are able to put their efforts into their courses, as a huge financial burden has been lifted. 35 out of 36 of the Harvey Family Foundation scholars either have transferred to a four-year institution or have been retained at RRCC to complete their coursework before transferring. 21 out of the 36 scholars have successfully transferred from RRCC to CSM. We are extremely proud of the RRCC Harvey Family Foundation scholars, and the results show that they truly appreciate the award given to them and are taking full advantage of it.

This past year, the Harvey Family Foundation notified the RRCC Foundation, that a commitment had been made to fund transfer scholarships for community college students attending CSM. The RRCC Foundation and CSM Foundation then collaborated on a grant initiative through the Colorado Department of Higher Education that would allow a dollar for dollar match to double the impact of the Harvey Family Foundation transfer scholarship. Through this partnership, \$400K worth of scholarship dollars have been made available to community college students attending CSM for the 2019-2020 academic year. This is not only an amazing opportunity for our RRCC Harvey Family Foundation scholars, but for all RRCC students who have a goal of continuing their education at CSM.

# **ALBINSSON GRANT PROGRAM**

The Dr. Agneta Albinsson Professional Development Grant Program was established in 2013, with a mission to support professional development opportunities for RRCC faculty teaching in science and healthcare programs. Dr. Agneta Albinsson and her husband, Mats Wahlstrom, created the program to aid RRCC in its ability to attract and retain highly skilled faculty in science and health. Dr. Albinsson has served as a member of the RRCC Board of Directors since 1998. As someone who studied and worked within various science and health fields, she saw the importance of giving RRCC faculty the opportunity to broaden their professional development. This in turn, would help our RRCC students excel in those fields.

Each Academic Year full-time and adjunct faculty are encouraged to submit a proposal. Faculty members from the following disciplines are eligible to apply: Astronomy, Biology, Chemistry, Diagnostic Medical Sonography, Emergency Medicine, Environmental Science, Geology, Health Professional, Holistic Health Program, Math, Nurse Aide/Nursing, Physician Assistant Program, Physics, Pre-Engineering, and Radiologic Technology. Since its inception, the

Each Albinsson Professional Development Grant awardee is required to submit an activity report when they complete their professional development. Below are a few excerpts from those activity reports, which show just how valuable the experience was for the individuals. The impact is felt throughout RRCC.

#### Jennifer Kroetch, Dean of Instruction:

Because of the Albinsson grant, Nursing Faculty at RRCC have been doing programmatic professional development to bring simulation to more classes at Red Rocks Community College. We are currently piloting a training program for Nurse Aide Faculty to do intentional simulation in class. The feedback from students has been nothing but positive. We are also delivering the program has awarded 26 RRCC faculty, with just under \$50K worth of grant funds. RRCC faculty have taken full advantage of this generous opportunity. Faculty have used their awards to take doctorate level courses, go on field survey/research trips, obtain professional memberships, or attend specialized trainings or conferences in their field.

Our faculty have deep gratitude for the unique opportunities that the Dr. Agneta Albinsson Professional Development Grant Program provides for them. Many of the requests we receive annually would not fit into normal departmental budgets, so this gives a chance to award outstanding faculty who are looking to further their knowledge. This does not just help the RRCC faculty awarded, but also helps their fellow faculty and RRCC students. Many faculty have enthusiastically told us that they cannot wait to get in the classroom and apply the new methods and techniques that they have learned from being awarded the grant.

Student success is directly influenced by faculty excellence, and RRCC strives to deliver exceptional educational experience to all students by recruiting, recognizing, and rewarding exceptional faculty. The RRCC Foundation wanted to make sure that we were adhering to the above statement. In 2001, the Endowed Teaching Chair program was launched, and an amazing journey has since followed.

In order to reward outstanding faculty, the RRCC Foundation needed to collaborate with people in the community who were just as committed to education as RRCC. The Mike Leprino Family Foundation and the Swede Johnson/Coors Company funded the first two Endowed Teaching Chairs. Candace Garrod, the first Swede Johnson/ Coors Company Endowed Teaching Chair winner, stated how impactful the award was to her as an educator: "I was ecstatic when I received the award, and felt that my teaching skills were really going in the right direction. It really gave me the boost I needed to continue to excel in the classroom."

The Mike Leprino Family Foundation and the Swede Johnson/Coors Company were joined by the Student Voice Endowed fund in 2004, as the three main Endowed Teaching Chair awards. The award rotates each year, and each faculty who is awarded is given a three-year salary enhancement of \$5,000 per year in addition to \$2,500 per year for professional development. That is \$22,500 worth of award money over three years! RRCC is the only Coll

award money over three years! RRCC is the only College in the Colorado Community College System with a multi-year faculty award.

Our Endowed Teaching Chair winners take full advantage of the generous opportunities afforded to them by the Mike Leprino Family Foundation, Swede Johnson/Coors Company, and Student Voice Endowed fund. We have seen winners do some amazing things with their award money. An Art faculty member spent time studying sculpturing in Italy, an English faculty member participated in an Ireland folklore writing conference, a Sociology faculty member traveled to Uganda and Rwanda to study travel abroad opportunities for RRCC students, and many more!




