Curriculum Proposal Cover Sheet discussion: the cover sheet has some questions that are school specific, but the courses are not school specific. While thinking about planning, it's important for successful courses to have both the classroom space and the lab space and equipment (e.g., Astronomy at Arvada). Special topics course considerations: the course isn't supposed to be taught as a "special topics" for more than 1 year, but RRCC has sort of an "only once" type of policy. Concerns about having to have a certain number of certificate completers before the course is approved could threaten continuing education courses. There is still a need for continuing ed. courses.

Guided pathways: Are courses going to disappear if they don't show up on a plan? What about the continuing ed. courses with under 15 students every semester? Lynnette is planning to meet with Linda Comeaux about this for clarification and to share concerns of the faculty.

Be thinking about procedures to put in place to approach offering new classes at other campuses, etc.
